## 2025 Myrtle Beach/Grand Strand Tournament Rules and Regulations

1. This tournament is certified and operated under the tournament rules of, and open to all **TNBA and USBC members**. Please submit a copy of your current membership (TNBA and USBC) cards along with your application. Any bowler who cannot present their card prior to bowling will be required to purchase a card on site, at a cost of **\$30 TNBA and \$32 USBC**.
2. The tournament will consist of **MIXED TEAMS**, a combination of four (4) bowlers, men/women; **& DOUBLES** (any combination, male or female). **OPTIONAL SINGLES** will be offered while bowling doubles, with separate singles for men and women. If bowling more than one team or doubles, please submit entries on different forms, and at the same time. **HANDICAP** will be **90%** of **210**, figured individually for men and for women. **TOURNAMENT DEADLINE IS FEBRUARY 1, 2025**. **If you wish to RE-ENTER any event, you may do so (if space is available), by submitting a separate entry form by the registration deadline.** There will be **NO WALK-INS**, however, you may re-enter on site, if you had previously bowled, and if space is available.
3. **ENTRY FEE** is **\$45.00** per event, and **OPTIONAL Singles, while bowling Doubles**, will be **\$15**. All **FEES** in the form of **BANK** or **CERTIFIED CHECK** and **MONEY ORDERS** are to be made payable to **Myrtle Beach/Grand Strand Senate of TNBA**, and it must accompany the application.
4. The entry application must include the **FULL NAME (No nickname), INDIVIDUAL ADDRESSES, TNBA, AND USBC NUMBERS for EACH BOWLER**. Omission will delay processing the application.
5. Bowlers must use their highest USBC sanctioned league average, based on 21 games for the 2023-2024 season or current league average if it is 10 or more pins higher. **NO SUMMER OR STRING BOWLING LEAGUE AVERAGES MAY BE USED**. Sport and Challenge League averages must be converted per USBC Conversion Chart. All others must use the highest current average at the time of bowling. A league sheet from the League Secretary is required to verify current averages. If the bowler does not qualify with any of the above, the bowler must enter with a 210 average. The **10-PIN Rule** will apply. **USBC rule 319a-2** will apply. **USBC rule 319d** – Reporting Prize Winnings (SS# required with \$300 or more winnings in a single event, etc.) will apply. **USBC rule 319c** – Average Adjustment will apply. If you have been re-rated before, you must submit your re-rated average, even if you do not accept the adjusted average. Failure to do so, will disqualify you. Please check at the registration table prior to bowling.
6. Multiple entries will be permitted, but a bowler may cash only once with the same partner. **PRIZE FEE** will be returned 100%. One prize will be awarded for at least every ten (10) entry in each event. Any bowler who has held a PBA membership card within the past five (5) years, will not be allowed to bowl in this tournament. A bowler may only bowl on one entry per squad.
7. Team Captains must report to the Tournament Office at least one hour before the scheduled time to bowl and submit any information that is missing or required.
8. **Bowlers are responsible for verifying their own averages**, whether submitted by the bowler, the team captain, or others. If the submitted average for the bowler is higher than the true average, the bowler must bowl with the lesser handicap, and no additional pins will be given. If the submitted average is less than the true average, the bowler will forfeit all prize money and any money he/she helped to earn. Any change in average must be submitted prior to bowling. (See **USBC rule 319a-3 and 319a-4**).
9. **NO** change in line-up will be allowed once the application has been submitted and processed.
10. Replacements and substitutions will be permitted, but the bowler must bowl in the position of the original bowler. All rules and regulations herein likewise apply to replacements and substitutions. All changes must be made prior to bowling.
11. Errors in scoring must be reported to the Tournament Office within 24 hours after games bowled.
12. Tardy players will start in the frames being bowled, with **ZERO** given for each frame missed. If a team refuses to start because a full line-up is not present, all games which they decline to bowl will be forfeited. **NO** blind scores will be permitted. The bowler must bowl on the same lanes, and at the same time, that his/her team bowls.
13. After the entries have been received, no fees shall be refunded, except in dire emergencies, fires, natural disasters, etc., over which management has no control.
14. Any appeal or protest regarding tournament scores or rules must be made in writing to the tournament manager within 72 hours of the infraction. The action of the committee shall be final, unless a written appeal is made, in accordance with USBC rules.
